## **RESOLUTION NO.16-304**

A RESOLUTION OF THE BOARD OF DIRECTORS OF THE MISSION HILLS COMMUNITY SERVICES DISTRICT APPROVING A REVISED NOTICE OF PUBLIC HEARING FOR RATE HEARINGS CONDUCTED PURSUANT TO ARTICLE XIIID, SECTION 6 OF THE CALIFORNIA CONSTITUTION

(rescinds resolution 16-302)

**WHEREAS**, the Mission Hills Community Services District (the "District") is a community services district duly formed under California Government Code Section 61000 et. seq. to provide community services within the District's service area, including water, sewer and street sweeping services; and

**WHEREAS,** the District owns, operates and maintains a water system and sanitary sewer system including treatment facilities, percolation ponds, water and sewer mains, and other appurtenances, facilities and necessary improvements; and

**WHEREAS**, the District is considering increasing water and sewer rates in order to continue to provide safe and reliable water and sewer services;

**WHEREAS,** Article XIIID, Section 6 of the California Constitution requires the District to provide written notice of proposed fees and charges to all property owners and customers of the District; and

**WHEREAS**, on March 10, 2016, the District adopted Resolution No. 16-302 approving the Notice of Public Hearing regarding the proposed rate increase for water and sewer services; and

**WHEREAS**, it has come to the attention of the District that the Notice of Public Hearing did not include a complete description of the proposed rates; and

**WHEREAS**, the District has prepared a revised Notice of Public Hearing attached hereto as Exhibit "A," regarding the proposed rate increase for water and sewer for distribution to all property owners and customers of the District.

**NOW, THEREFORE, BE IT RESOLVED** by the Board of Directors of the Mission Hills Community Services District to approve the revised Notice of Public Hearing regarding the proposed rate hearings conducted pursuant to Article XIIID, Section 6 of the California Constitution attached hereto as Exhibit "A" and incorporated herein by this reference, for mailing to all property owners and customers of the District.

**BE IT FURTHER RESOLVED** that this Resolution supersedes Resolution No. 16-302 adopted on March 10, 2016.
